**ORDER**

By the Telecommunications Access Policy Division, Wireline Competition Bureau:

1. This Order dismisses the Request for Review filed by Bullitt County School District (Bullitt County), Shepherdsville, Kentucky.<sup>1</sup> Bullitt County seeks review of a decision issued by the Schools and Libraries Division (SLD) of the Universal Service Administrative Company (Administrator) on March 29, 2002.<sup>2</sup> The Commission received Bullitt County's Request for Review on May 31, 2002.<sup>3</sup>

2. For requests seeking review of decisions issued on or after August 13, 2001 under section 54.720(b) of the Commission's rules, any such appeal must be filed with the Commission or SLD within 60 days of the issuance of the decision that the party seeks to have reviewed.<sup>4</sup>

3. ACCORDINGLY, IT IS ORDERED, pursuant to authority delegated under sections 0.91, 0.291, and 54.722(a) of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 54.722(a), that the Request for Review filed on May 31, 2002, by Bullitt County School District, Shepherdsville, Kentucky, IS DISMISSED.
