## WIRELINE COMPETITION BUREAU SEEKS COMMENT ON ALLTEL NEBRASKA, INC.'S PETITION FOR WAIVER OF SECTION 54.313 OF THE COMMISSION'S RULES

### PLEADING CYCLE ESTABLISHED

On March 23, 2004, ALLTEL Nebraska, Inc. (ALLTEL) filed a petition with the Commission for a waiver of section 54.313 of the Commission's rules, so that ALLTEL can obtain federal high-cost universal service support for its service in Nebraska for the first and second quarters of 2004.<sup>1</sup> Pursuant to the Commission's rules, before non-rural carriers may obtain certain high cost universal service support, state commissions must file a state certification of support in accordance with certain deadlines.<sup>2</sup> The timing of the state commission filing affects the period for which non-rural carriers receive high cost universal service support.<sup>3</sup> In its petition, ALLTEL explains that, because it was not eligible to obtain certain high cost universal service support in Nebraska in prior years, the Nebraska Public Service Commission (Nebraska PSC) did not file the appropriate state certification in time for ALLTEL to receive support for all four quarters of 2004.<sup>4</sup> ALLTEL further explains that the Nebraska PSC concluded a proceeding in March 2004 and found that ALLTEL properly demonstrated that it would use the federal high cost universal service support for appropriate purposes.<sup>5</sup> For these reasons, ALLTEL requests that the Commission grant, pursuant to section

1.3 of the Commission's rules, a waiver of section 54.313 to treat the Nebraska PSC state certification as timely filed in order for ALLTEL to obtain support for all of 2004.<sup>6</sup>

We invite comment on the Petition for Waiver. Pursuant to applicable procedures set forth in sections 1.415 and 1.419 of the Commission's rules, interested parties may file comments on or before **June 10, 2004**; and reply comments on or before **June 24, 2004**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 Fed. Reg. 24121 (1998).

Comments filed through the ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send an e-mail to [ecfs@fcc.gov](mailto:ecfs@fcc.gov), and should include the following words in the body of the message, "get form <your e-mail address>." A sample form and directions will be sent in reply. Parties who choose to file by paper must file an original and four copies of each filing. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number. Filings can be sent by hand or messenger delivery, by commercial overnight courier, or by first-class or overnight U.S. Postal Service mail (although we continue to experience delays in receiving U.S. Postal Service mail). The Commission's contractor, Vistrionix, Inc., will receive hand-delivered or messenger-delivered paper filings for the Commission's Secretary at 236 Massachusetts Avenue, N.E., Suite 110, Washington, D.C. 20002. The filing hours at this location are 8:00 a.m. to 7:00 p.m. All hand deliveries must be held together with rubber bands or fasteners. Any envelopes must be disposed of before entering the building.
