WIRELESS TELECOMMUNICATIONS BUREAU GRANTS MULTICHANNEL VIDEO DISTRIBUTION AND DATA SERVICE LICENSES TO SOUTH.COM LLC

AUCTION EVENT NO. 53

Report No. AUC-53 (Auction No. 53)

On January 27, 2004, the Federal Communications Commission completed the auction of 214 Multichannel Video Distribution and Data Service (“MVDDS”) service licenses (“Auction No. 53”).¹ On June 15, 2004, the Wireless Telecommunications Bureau announced that, based upon a preliminary review of the long-form applications, it was accepting for filing the applications for winning bidders in Auction No. 53.² Upon further review and examination, the application of South.Com LLC listed in Attachment A has been found to be complete and in conformance with the Commission’s rules. Furthermore, the Commission has received full and timely payment, as required by section 1.2109(a) of the Commission’s rules, for the licenses listed in Attachment A.³
