COMMENTS SOUGHT ON SBC MICHIGAN REQUESTS FOR LIMITED MODIFICATION OF LATA BOUNDARIES IN MICHIGAN

By this Public Notice, we seek comment on nine petitions filed by SBC Michigan requesting modification of local access and transport area (LATA) boundaries to provide flat or message-rated, non-optional expanded local calling service (ELCS) between various exchanges in Michigan, as required by Michigan law.¹

Interested parties may file comments concerning this request on or before **February 19, 2004**, and reply comments on or before **February 26, 2004**. All filings must reference **WC Docket No. 04-27**. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 Fed. Reg. 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Only one copy of an electronic submission must be filed. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send e-mail to ecfs@fcc.gov, and should include the following words in the subject line "get form <your e-mail address>." A sample form and directions will be sent in reply.
