Section 214 Application

Applicant: McLeodUSA Telecommunications Services, Inc.

On **January 8, 2004**, **McLeodUSA Telecommunications Services, Inc.** (McLeodUSA or Applicant) located at **6400 C Street SW, Cedar Rapids, Iowa 52406-3177** filed an application with the Federal Communications Commission (FCC or Commission), requesting authority under section 214(a) of the Communications Act of 1934, as amended, 47 U.S.C. § 214(a), and section 63.71 of the Commission's rules, 47 C.F.R. § 63.71, to discontinue the provision of certain U.S. domestic interstate telecommunications service in certain geographic areas.

McLeodUSA states that it provides interstate special access digital subscriber line (DSL) service, used for high-speed internet access, in Oklahoma City, Oklahoma. McLeodUSA indicates that it seeks to discontinue its provision of this service only within the central offices designated by common language location identifier codes OKCYOKCE and OKCYOKME. McLeodUSA states that it is non-dominant with respect to this service. The application indicates that McLeodUSA plans to discontinue service on February 15, 2004, or as soon thereafter as the necessary governmental approval can be obtained. McLeodUSA further indicates that, in accordance with the requirements of section 63.71(a) of the Commission's rules, it provided written notice of its planned discontinuance to all affected customers on January 2, 2004.

In accordance with 47 C.F.R. § 63.71(c), the application will be deemed to be automatically granted on the thirty-first (31st) day after the release date of this notice, unless the Commission has notified McLeodUSA that the grant will not be automatically effective. Accordingly, pursuant to section 63.71(c), absent further Commission action, McLeodUSA may not terminate service until February 15, 2004. The Commission will normally authorize proposed discontinuances of service unless it is shown that customers or other end users would be unable

to receive service or a reasonable substitute from another carrier, or that the public convenience and necessity would be otherwise adversely affected.

This proceeding is considered a "permit but disclose" proceeding for purposes of the Commission's *ex parte* rules, 47 C.F.R. §§ 1.1200-1.1216. Comments objecting to this application must be filed with the Commission on or before **January 29, 2004**. Such comments should refer to **WC Docket No. 04-8 and Comp. Pol. File No. 669**. Comments should include specific information about the impact of this proposed discontinuance on the commenter, including any inability to acquire reasonable substitute service. Comments may be filed using the Commission's Electronic Comment Filing System (ECFS) or by filing paper copies. See *Electronic Filing of Documents in Rulemaking Proceedings*, 63 Fed. Reg. 24121 (1998). Comments filed through the ECFS can be sent as an electronic file via the Internet to <<http://www.fcc.gov/e-file/ecfs.html>>. Generally, only one copy of an electronic submission must be filed. If multiple docket or rulemaking numbers appear in the caption of this proceeding, however, commenters must transmit one electronic copy of the comments to each docket or rulemaking number referenced in the caption. In completing the transmittal screen, commenters should include their full name, U.S. Postal Service mailing address, and the applicable docket or rulemaking number. Parties may also submit an electronic comment by Internet e-mail. To get filing instructions for e-mail comments, commenters should send e-mail to ecfs@fcc.gov, and should include the following words in the subject line "get form <your e-mail address>." A sample form and directions will be sent in reply.

Parties who choose to file by paper must send an original and four (4) copies of the comments to the Office of the Secretary, Federal Communications Commission, 445 12th Street, S.W., Room TW-A325, Washington, D.C. 20554. If more than one docket or rulemaking number appears in the caption of this proceeding, commenters must submit two additional copies for each additional docket or rulemaking number.
