Assignment of License Authorization Applications, Transfer of Control of Licensee Applications, and *De Facto* Transfer Lease Applications Accepted for Filing

Because of recent events in Washington, D.C., resulting in the disruption of regular mail delivery and of the processing of other deliveries, the Commission released, on November 29, 2001, an Order temporarily amending certain procedural rules on an emergency basis. See "Implementation of Interim Electronic Filing Procedures for certain Commission filings", FCC 01-345, Order, (rel. November 29, 2001). Certain pleadings must be filed electronically (electronic mail or facsimile), by hand delivery, or by overnight delivery service other than U.S. Postal Service Express and Priority Mail.

Below is a listing of applications, subject to applicable pre-grant notice and petition procedures, that upon initial review were accepted for filing. The Commission may return any of the applications, if upon further examination, it is determined they are defective or not in conformance with the Commission's rules and regulations.

Final action will not be taken on applications requesting an Assignment of Authorization or Transfer of Control of FCC licenses earlier than 31 days following the date of the public notice, except for applications not requiring a 30-day notice period (See Section 309(c) of the Communications Act, as amended) and for applications subject to streamlined approval procedures (See Section 1.948(j)(2) of the Commission's rules). Final action will not be taken on applications involving Assignment of Authorization or Transfer of Control of FCC licenses that are subject to streamlined approval procedures, *de facto* transfer leases, including subleases, and transfer of control or assignment of existing lease rights earlier than 15 days following the date of the public notice, except for applications not requiring a 14-day notice period (See Section 309(c) of the Communications Act, as amended).

- * Note the 10-digit file number listed on the Public Notice;
- * Access the ULS (instructions are on the internet at <http://www.fcc.gov/wtb/uls>);
- * From the ULS Online Systems Menu in the center of the screen, scroll down to the "Search" section and click on the "Applications" button;
- * On the Application Search Screen, select the Search Type for "Transfers and Assignments" and click on the "Continue" button;
- * Type the application's 10-digit file number into the "File Number:" field on the Application Search screen;
- * Scroll to the bottom of the page and click the "Search" button;
- * When the search is completed, the application will be listed by file number on the screen;
- * Click on the file number (in hypertext) to view the application and attachments.

Exclusions: Transfer and Assignment applications filed for the Multipoint Distribution and Multichannel-Multipoint Distribution Services (MD) and Instructional Television Fixed Service (VX) are not yet available in the ULS database.
