**NOTICE OF VIOLATION**

**Released: April 28, 2004**

By the District Director, Chicago Office, Enforcement Bureau:

1. This is a Notice of Violation ("Notice") issued pursuant to Section 1.89 of the Commission's Rules,<sup>1</sup> to Panhandle Eastern Pipe Line CO.

2. On April 13, 2004, an agent of the Commission's Chicago Office inspected the antenna structure, ASR# 1007691, located at Pleasant Hill, Illinois, and observed the following violation(s):

- a. 47 C.F.R. § 17.17(a): "...structures authorized prior to July 1, 1996 ... retain their present painting and lighting specifications..." The Antenna Structure Registration, FCC Form 854, specifies the structure listed above is required to have red obstruction lighting. The antenna structure is equipped with white lighting systems rather than red obstruction lighting.

3. Pursuant to Section 308(b) of the Communications Act of 1934, as amended,<sup>2</sup> and Section 1.89 of the Commission's Rules, Panhandle Eastern Pipe Line CO., must submit a written statement concerning this matter within 20 days of release of this Notice. The response must fully explain each violation, must contain a statement of the specific action(s) taken to correct each violation and preclude recurrence, and should include a time line for completion of pending corrective action(s). The response must be complete in itself and signed by a principal or officer of the licensee with personal knowledge of the matter. All replies and documentation sent in response to this Notice should be marked with the File No. and NOV No. specified above, and mailed to the following address:
